Movie Starts after Sundown, 7pm

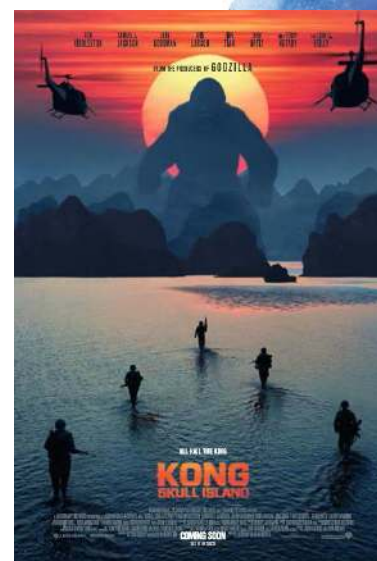

Suitable for persons aged 13 and above but parental guidance is advised for children below 13.

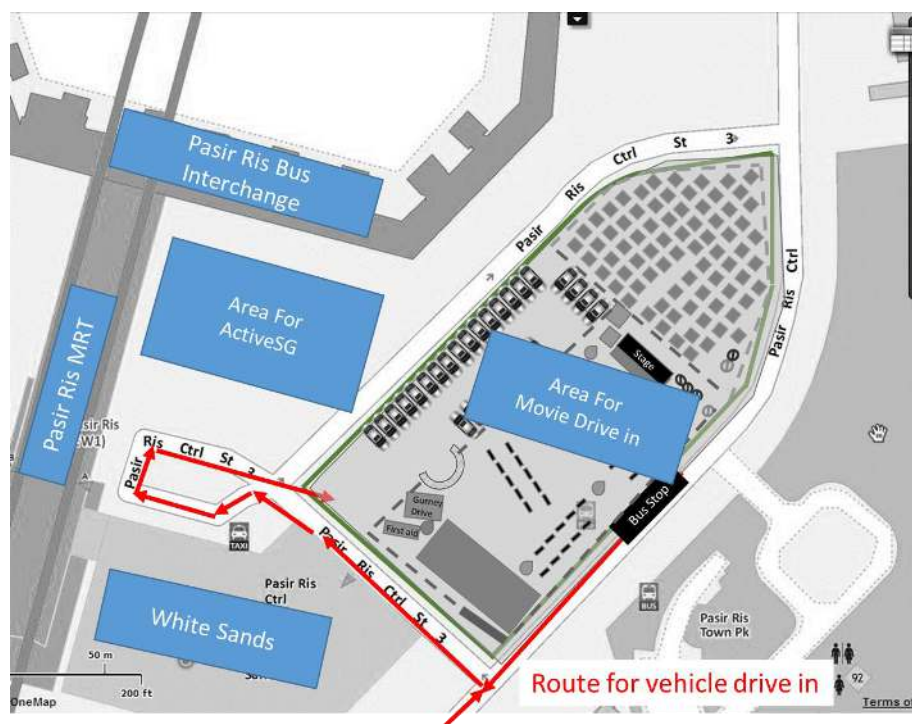

- Child ticket holders are to be below 12 years old.
- Admission is subject to tickets produced at the entry point. Space allocation is based on first-come-first-served basis, entry commences from 2pm.
- Movie Drive in will be held at the field opposite White Sands.

Movie Drive-In (for vehicles)

- Admission is subject to tickets produced at the entry point. Movie starts after sundown at 7.30pm and gates are open for drive in admission at 12pm. No vehicle entry permitted into the venue once movie commences.
- Drive-in lots will be allocated based on first-come-first serve basis. Drivers need to follow parking controls and restrictions from Event staff upon arrival. When necessary, larger sized vans and trucks will be directed to park at a designated area.
- No vehicle lighting is allowed while the movies are being shown. Headlights, parking lights, daytime running lights, and all interior lights must remain off. Laser pointers are not permitted for use at the drive-in. The Event staff reserve the right to confiscate any laser pointers at the event venue with no refund.
- Limited to maximum of 50 to 80 cars, depending on-site condition.
- Participants can enjoy free flow of candy floss and popcorn. Items are limited while stocks last.



Picnic Mats (Area)

- Guests are encouraged to bring their own picnic mats. Movie starts after sundown at 7pm and picnic area opens for admission at 2pm.
- Free sitting. Smoking is strictly prohibited.
- Participants can enjoy free flow of candy floss, popcorn, bring home a White Sands mini fan, sculpted balloon, and play at bouncy castles and game booths for free. Items are limited while stocks last.

ActiveSG Activity Zone
